SCOPE AND UPDATES TO THIS POLICY

- 1. device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- 2. behavioral usage of the App.
- 3. the type, version, brand, language and operating system of device.
- 4. email address.
- 5. the type and operator of network (such as Mac address).

USE OF INFORMATION

We use information collected for the purposes of:

- 1. providing the App and Service.
- 2. understanding and improving our Service, and developing new or improved App.
- 3. personalizing your experience.
- 4. helping us detect abuse, fraud, and illegal activity on the App.

5. communicating with you, including to notify you about changes in our Service.

DISCLOSURE OF INFORMATION

We may disclose personal information:

- with vendors, consultants and other service providers working on our behalf.
- 2. for compliance purposes, such as when reasonably necessary to protect the security and safety of our users or the App, or when permitted by law.
- 3. with other companies within our group.

SAFEGUARD YOUR PERSONAL INFORMATION

We determine and implement systematic, clearly defined, manageable and sustainable policies and procedures for the security of your personal information.

RETENTION OF PERSONAL INFORMATION

We endeavor to retain personal information in accordance with applicable law. We will keep your personal information for the minimum period necessary for the purposes set out in this Policy, namely (i) for as long as you are a user of the App; or (ii) for as long as your personal information is necessary in connection with the lawful purposes set out in this Policy; (iii) for as long as is reasonably necessary for business purposes related to provision of the App; or (iv) for as long as is reasonable necessary to resolve disputes, establish legal defenses, conduct audits, pursue legitimate business purposes, enforce our agreements, comply with applicable laws.

CHILDREN'S PRIVACY

The privacy of children under the age of 13 is important to us. The App is not directed at children. If we become aware that personal information has been collected on the App from a child, we will delete this information. If you believe there is a user who is below the age of 13, please contact us.

YOUR PRIVACY CHOICES AND RIGHTS

You may submit a request to know, access, correct or delete the information we have collected from or about you. You may also request to withdraw your consent at any time. However, the withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. You have other rights entrusted by related laws and regulations.
